GENERAL PROVISIONS

- 1. The minimum pay for each job classification is set out in Appendix A.
- 2. All new employees will start at base wage and serve a 60 work-day supervised probationary period.

SPECIAL PAY PROVISIONS REGARDING BUS DRIVERS

- 1. Regularly established bus routes will be paid at the rate of \$46.35 per route regardless of the hours required to complete the route and perform the related duties.
- 2. It is understood that the rate provided in paragraph 1 of this Section, compensates the employee for all necessary pre-trip and post-trip procedures and student discipline events that the driver may be required to spend time on.
- 3. Any and all required driver meetings will be paid at the employee's hourly wage.
- 4. Activity trips shall be paid on an hourly basis per hour for all driving time as per the contracted amount.

DURATION PERIOD

This agreement shall be effective from July 1, 2025, and shall continue in effect until June 30, 2027. The contract may reopen on an annual basis for the limited purpose of negotiating the base wage listed in Appendix A of the Master Contract.
